Notes:

1. The PM10 reading from Station 5 (Firehouse #10 [roof level]) on February 18, 2011 represents a partial average from 0000 to 1320 due to instrument malfunction; the daily average represents 56% of the 24 hour data set.
2. The PM10 reading from Station 5 (Firehouse #10 [roof level]) on February 19, 2011 represents a partial average from 1210 to 2400 due to instrument malfunction; the daily average represents 49% of the 24 hour data set.
3. Station 2 (Southeast Area [sidewalk bridge level]) and Station 2000 (Station 2 Field Duplicate) were removed from service on February 20, 2011 as per Amendment #18 to the September 2005 Ambient Air Monitoring Plan.
4. Station 25 (Southeast Area [ground level]) and Station 2500 (Station 25 Field Duplicate) began operation on February 19, 2011 as per Amendment #18 to the September 2005 Ambient Air Monitoring Plan.
